Providers Not Covered:

There are many physicians who are members of the Eisenhower Medical Center Medical Staff, who do not have a direct association with Eisenhower and who are not covered by the Eisenhower Medical Center Financial Assistance Policy. Some of these physicians (and in some cases, their nurse practitioners or physician assistants) may make financial assistance available to their patients – but, Eisenhower is not responsible for the administration of these physicians' financial assistance programs or billing practices. Although they are members of Eisenhower's Medical Staff, they are independent and practice independently. Some of these physicians may rent office space in a building that is located on the Eisenhower Medical Center Rancho Mirage hospital campus; those offices are not Eisenhower clinics and therefore, Eisenhower's Financial Assistance Policy does not apply to these offices.

Also, there are some physicians who do have a direct association with Eisenhower Medical Center but who are not covered under the Eisenhower Financial Assistance Policy. These providers include:

- 1. Anesthesiology
- 2. Radiology
- 3. Pathology
- 4. Certain Surgeons
- 5. Desert Orthopedic Center (orthopedic physician charges are not covered under the Eisenhower Financial Assistance Policy, but orthopedic facility charges are covered)

As physicians join Eisenhower, retire, or leave Eisenhower for other reasons, the list of covered providers may change frequently; so it is important for patients with questions about specific providers to contact EMC.
